### 1. DATA CONTROLLER

Your personal data is collected automatically when you browse the website <https://tavairports.com/>, perform transactions on the website, or contact us through our communication channels.

Your collected personal data will be processed in accordance with the fundamental principles set forth under the Law and within the personal data processing conditions specified in Article 5 of the Law, for the purposes outlined below.

Personal data obtained through the website shall be securely deleted, destroyed, or anonymized within a reasonable period once the purposes of processing cease to exist, without prejudice to the retention periods stipulated under applicable legislation.
