MANAGEMENT'S MESSAGE

ANOTHER REMARKABLE YEAR

2025 marked a year of strong performance and strategic delivery for TAV Airports. We served 113 million passengers across our global network, supported by continued growth in both international and domestic travel. This momentum translated into solid financial results, with revenue reaching EUR 1.82 billion and EBITDA rising to EUR 560 million, reflecting the resilience of our diversified business model.

In 2025, we successfully completed our 3A investment program—Almaty, Antalya, and Ankara—marking the culmination of a EUR 2.9 billion transformation across our core assets. Following the inauguration of Almaty's new international terminal in 2024, the program concluded with the delivery of major projects in Antalya and Ankara. These investments have materially enhanced both capacity and service quality across our portfolio. In Antalya, the comprehensive expansion across airside and landside operations has doubled the airport's annual capacity, significantly strengthening its position as a leading tourism hub in the Mediterranean. In Ankara, upgraded airside infrastructure and a new air traffic control tower reinforced the airport's long-term operational capabilities.

We continue to invest in our assets in line with growing demand and long-term opportunities. In Tbilisi, we secured a five-year concession extension, underpinned by a USD 150 million investment program designed to support the airport's next phase of growth and capacity expansion. In Madinah, we have launched a development program for a new international terminal, with a total planned investment around USD 250 million. Construction commenced in the second half of 2025 and is scheduled for completion in 2027, increasing the airport's capacity to 18 million passengers annually. In Almaty, where traffic has doubled since our acquisition, we have initiated a multi-phase investment program totaling EUR 315 million, extending through 2029 and covering a broad range of capacity and operational enhancements.

Looking ahead, we remain focused on sustainable growth, operational excellence, and creating long-term value. We thank our employees, partners, and stakeholders for their continued trust as we build on this strong foundation.

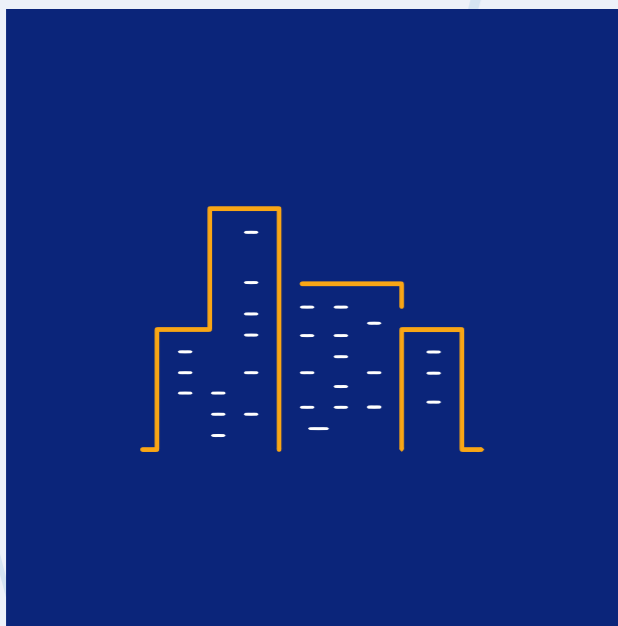

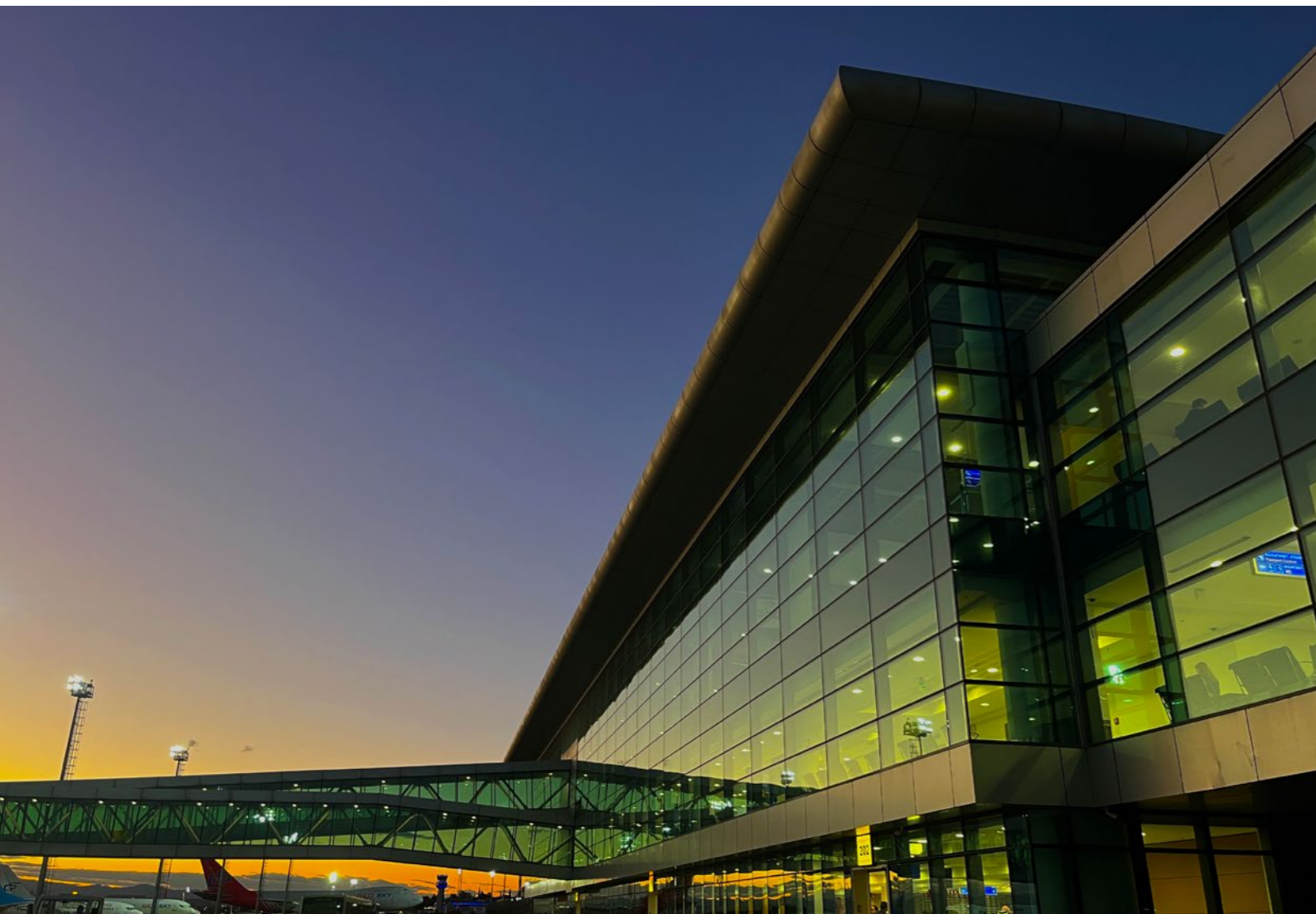

A Brand that **Transformed** the Airport Experience

Founded in 1997, TAV Airports became a success story built on the exceptional growth of global aviation during the last three decades.

Through technological changes and economic progress driven by globalization, air travel became increasingly accessible to different parts of the society across the globe. Deregulation of the industry diversified airline offers as legacy carriers were joined by low-costs and regionals. The hub-and-spoke system increased connectivity. Security became crucial in a globalized world without borders, faced with an evolving nature of threats. Global passenger traffic exceeded 9 billion in 2025, compared to around 2 billion in the 1990s.

Being long-term strategic investments, modern airports are required to adapt to a fast-changing world. TAV Airports, with its unique vertically and horizontally integrated business model, is among the brands that define the modern airport experience.

Through its subsidiaries, TAV Airports provides services at every point of the airport value chain. A portfolio of 15 airports in 8 countries and a highly skilled talent pool of 45 thousand people enables TAV Airports to devise and implement solutions customized to the needs of any airport project.

Milestones

- 2000**
Operations begin at Istanbul Ataturk Airport. Beginning of an extraordinary growth story, rising from 10 million passengers to joining the top 10 airports in the world in 2018.
- 2007**
TAV Airports goes public with a market capitalization of USD 1.7 billion.
- 2010**
The company adds 3 airports to its portfolio in Türkiye while expanding to Georgia, Tunisia, N. Macedonia to reach 10 airports in a decade.
- 2012**
Groupe ADP acquires a 38% stake of TAV Airports, the first step towards establishing the largest airport management platform globally. In 2017, Groupe ADP further increases its shares to 46%.

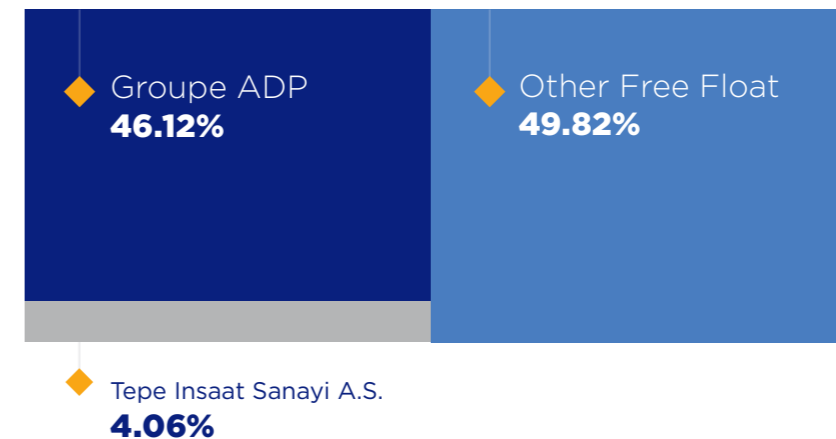
- 2018**
TAV Airports acquires 50% shares of Antalya Airport to partner with Fraport in the largest tourism hub of the Mediterranean.
- 2021**
A strategic move into Central Asia, TAV Airports acquires 85% shares of Almaty Airport in Kazakhstan.
- 2022**
Average maturity of the portfolio rose to 30 years, with extensions of Antalya and Ankara concessions beyond 2050.
- 2023**
TAV Airports became one of the few operators to exceed pre-pandemic traffic levels by 2023.
- 2024**
Inauguration of the new international terminal at Almaty Airport.



2025

Celebrating its 25th anniversary, TAV Airports successfully completed the largest investment program in its history. A total of EUR 2.9 billion invested, mainly in Almaty, Antalya and Ankara.

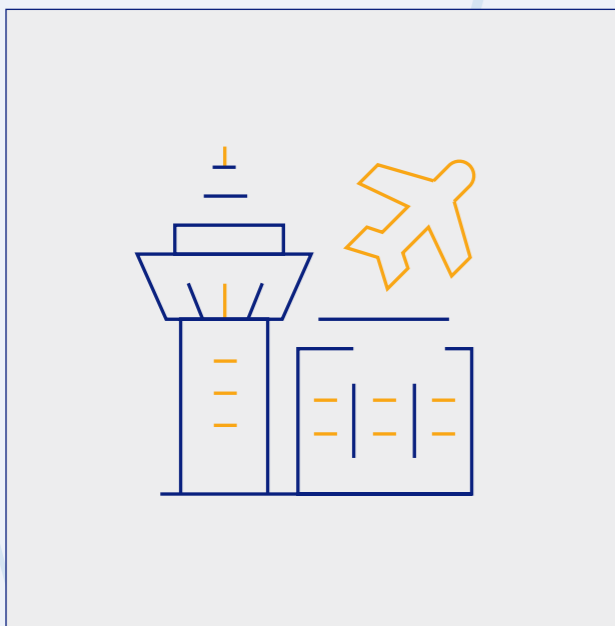
Ownership Structure (As of December 31, 2025.)

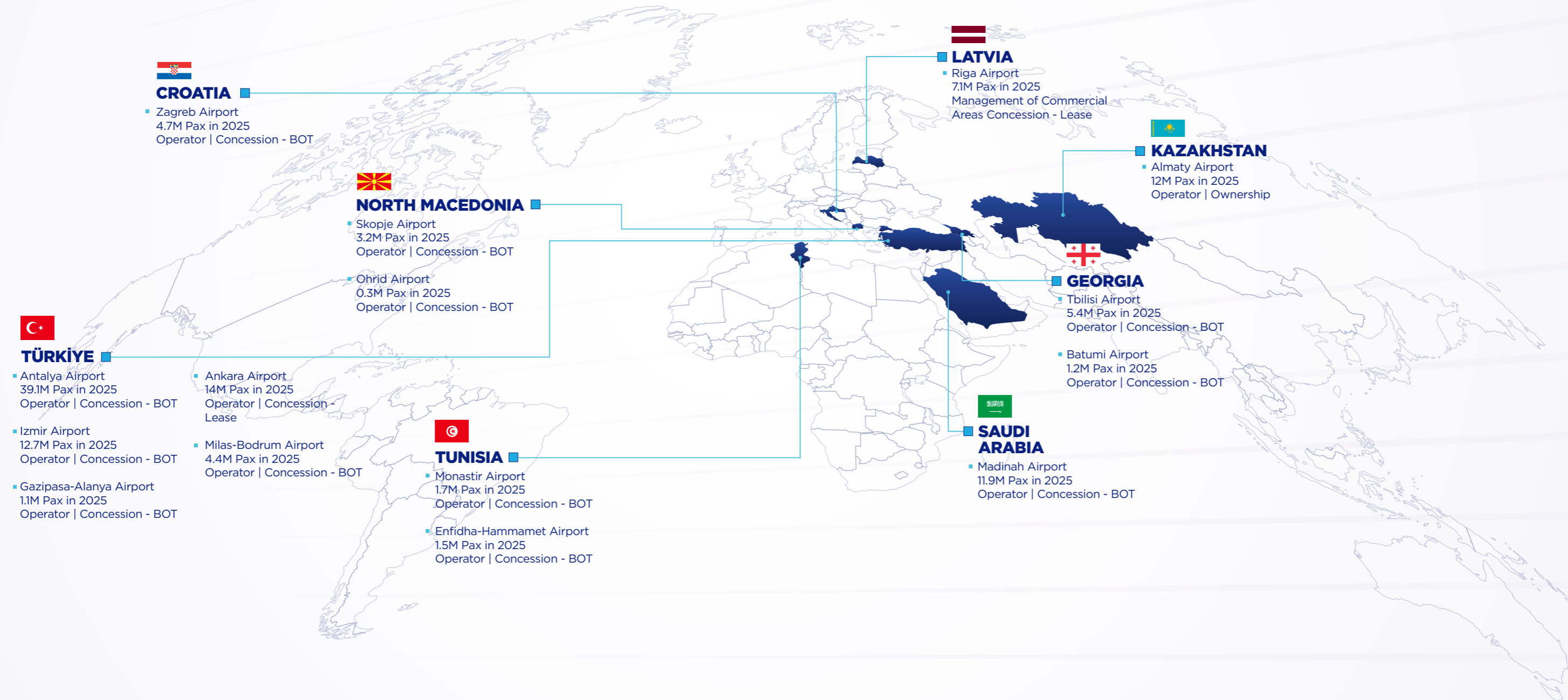

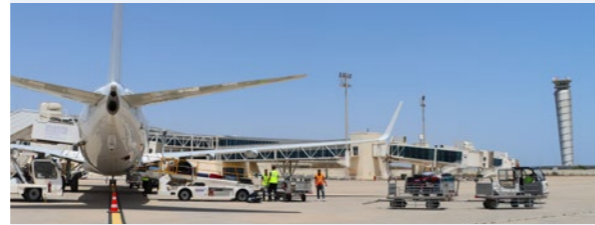

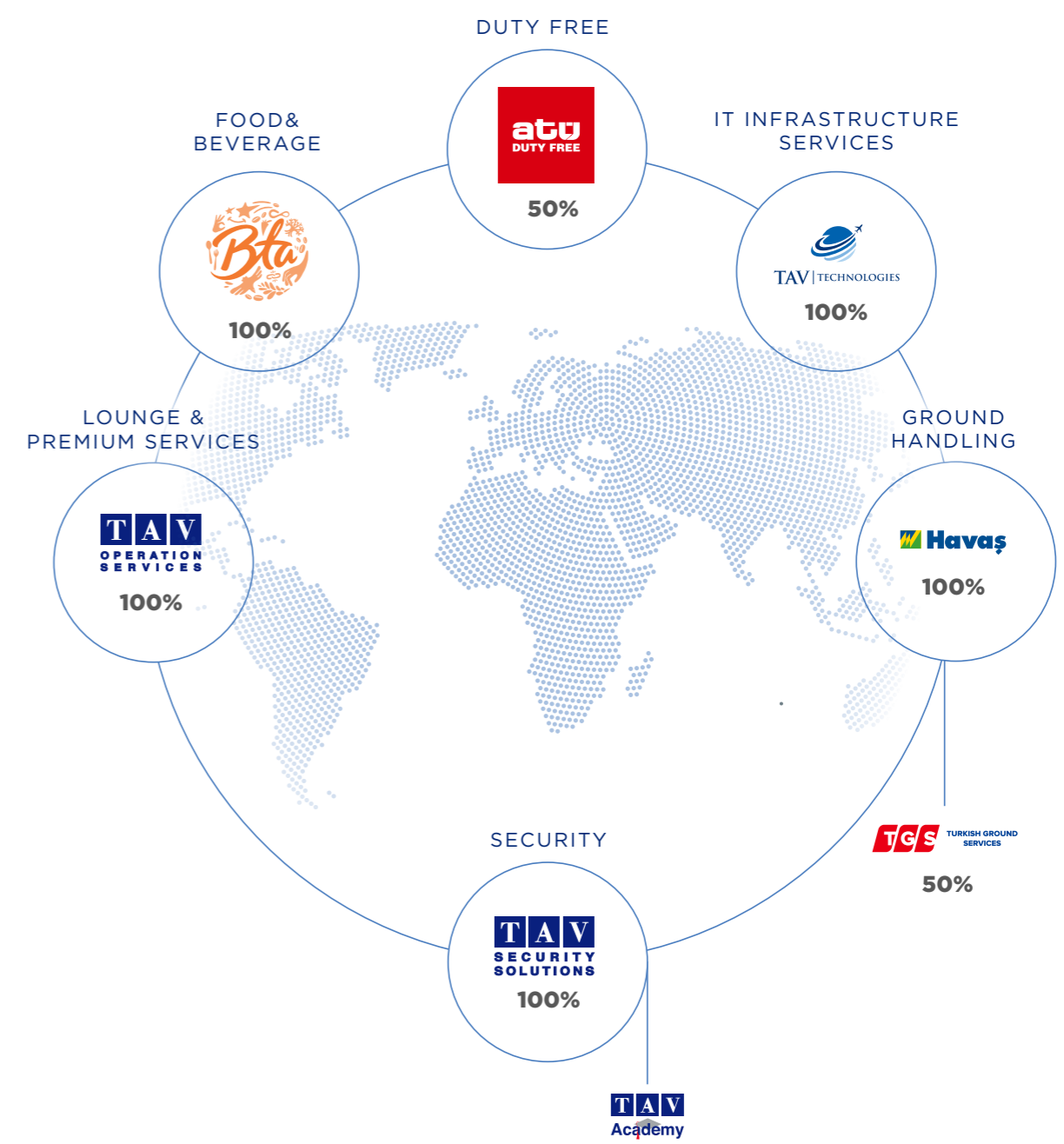

Almaty Airport

An investment of **EUR 257 million** has been made to build a brand-new international terminal, accompanied by upgrades to airside facilities, cargo operations, and fuel services.

The new terminal with more than **14 million passenger capacity** was opened in June 2024.



Ankara Airport

An investment of **EUR 210 million** was launched in 2023 on an EPC basis, covering a new **runway, carpark, 3.6 MW solar panels** and other various improvements which are completed in June 2025.



Antalya Airport

A first phase investment of **EUR 850 million** completed by **2025**.

The airport's capacity has increased to **65 million passengers** following the first-phase investment.



The second phase of investment is scheduled to begin in 2038, with the goal of increasing the capacity to **80 million passengers**.

Tbilisi Airport

Celebrating 20 years of excellence

TAV Airports has been operating Tbilisi International Airport since 2005 and recently extended its concession until the end of 2031 with a USD 150 million investment commitment. The investment program, launched in 2026, includes expansion of the terminal, apron, and car park, alongside improvements to the airport's commercial areas, designed to enhance capacity and passenger experience.

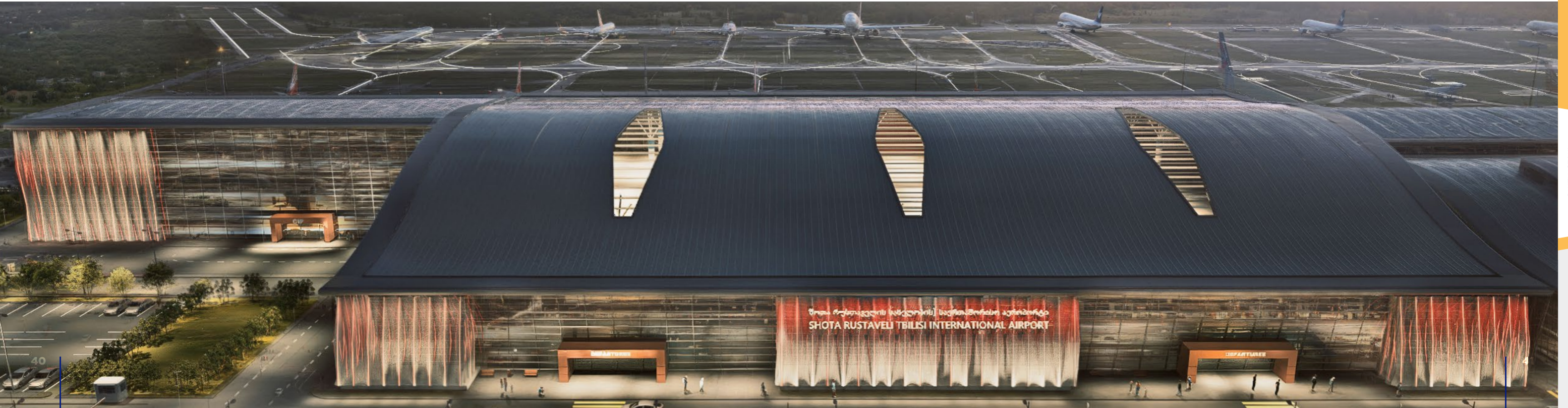

Almaty Airport

Almaty Airport is undergoing a comprehensive transformation through a multi-phase investment program, designed to significantly enhance infrastructure, capacity, and operational efficiency. Covering the 2025-2029 period, the program represents a total investment of over EUR 315 million across both airside and landside developments.

Airside works include the construction of new taxiways, refurbishment of existing runways, development of new passenger and cargo aircraft stands, as well as upgrades to terminal facilities and fuel infrastructure. Landside investments focus on supporting long-term growth through new office buildings, a training center, and modernization of parking facilities.

In the summer of 2025, a major investment program was launched, including the construction of a new international terminal and the refurbishment of the existing terminal. This program is designed to expand capacity, modernize infrastructure, and enhance the passenger experience for millions of travelers visiting the holy city.

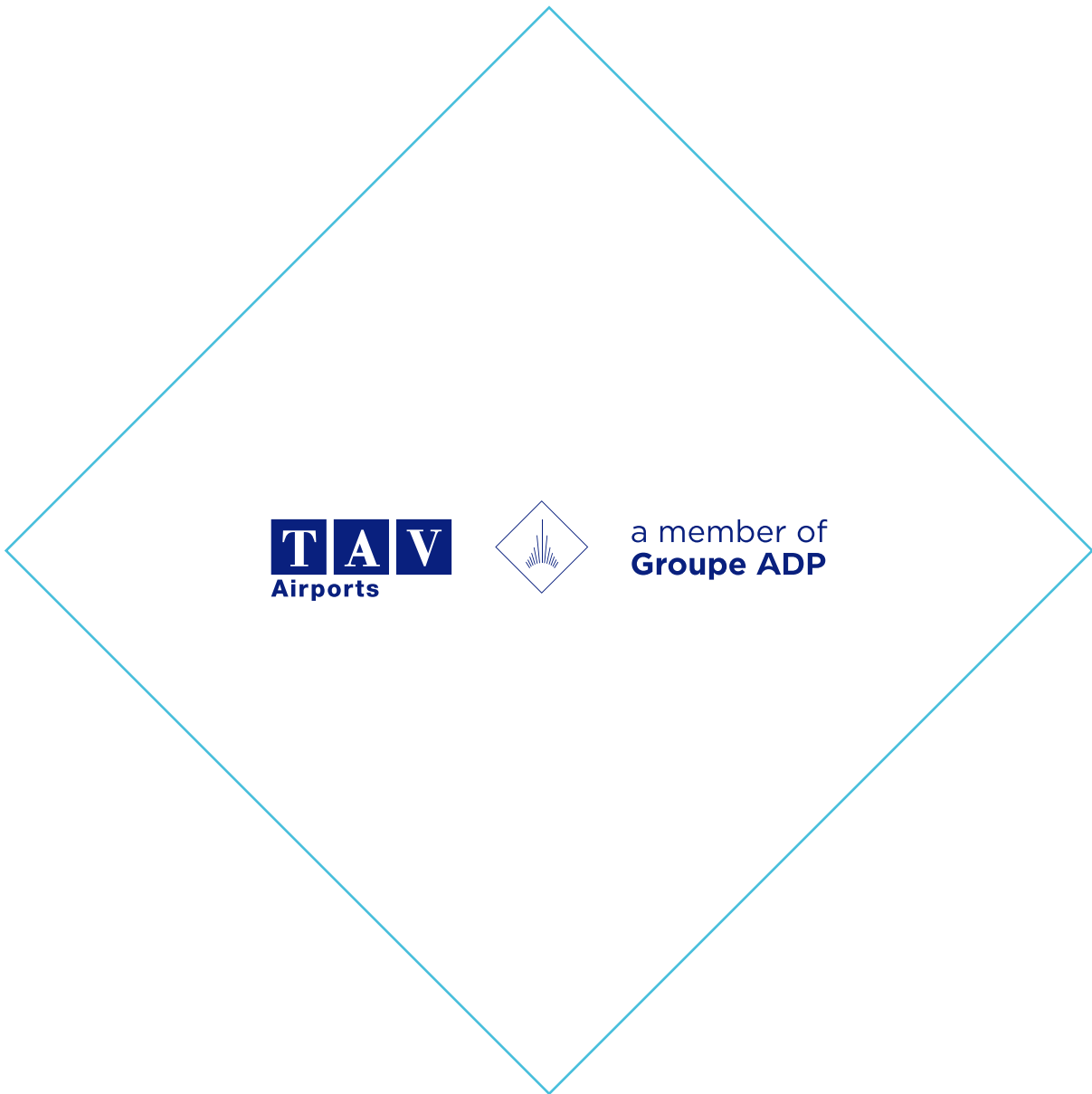
